# ELECTING STRONG CONSERVATIVE CANDIDATES TO CONGRESS

**By submitting the Freedom Caucus Fund donation form, you confirm that the following statements are true, accurate, and understood:**

1. I am a United States citizen or a lawfully admitted permanent resident.
2. I am at least 18 years of age.
3. Contributions to any candidate or committee made through the Freedom Caucus Fund are not deductible as charitable contributions for federal income tax purposes. Contributions will be disclosed publicly as required by federal law.
4. This contribution is made from my own funds, and these funds are not being provided to me by another person or entity for the purpose of making this contribution.
5. I am making this contribution with my own personal credit card or drawn off my own personal bank account and not with a corporate or business credit card or bank account or a card or bank account issued to another person. Contributions from corporations, labor unions, federal government contractors, and foreign nationals without green cards are not permitted.
6. Credit card and e-check donations are processed by **Stripe**, a third-party vendor, which transmits funds on behalf of the Freedom Caucus Fund to candidates' campaigns. I have read and accept the Terms of Service, Privacy Policy, and Refund Policy of **Stripe**.
7. By providing your email address, I agree to receive emails from Freedom Caucus Fund.
8. Contributions are voluntary and will be used for political purposes and in connection with federal elections. You have the right to refuse to contribute without reprisal or you may ask to contribute to other candidates. Any recommended amounts are merely a suggestion, and you may contribute more, less, or not at all.
9. Contributions made to candidates or committees are considered individual contributions and will be forwarded to the campaign committees of the candidates or committees to whom you have selected.
10. For the 2026 election cycle, the maximum contribution to individual candidates is \$3,500 per election (or \$7,000 for the primary and general elections combined). We do not keep track of contributions you may make to candidates through other fundraising programs – **you are responsible for keeping track of your contributions and allowable amounts.**
11. Federal law requires that we use our best efforts to obtain and report the name, mailing address, occupation and employer of individuals whose contributions exceed \$200 in a calendar year or who make donations directly to candidates or committees in any amount. We respectfully require that partners of partnerships and members of LLC's contribute individually, instead of using the bank account or credit card of their business entity.
12. To comply with federal law, and to process your donation, and to pay for your bank's and our credit card company's transfer fees, we have engaged a professional financial processing service called **Stripe**. They charge a service fee of 4% + \$0.30 for each donation they process for us. All benefitting candidates are informed of these service fees and pay them from the proceeds of your donation. Freedom Caucus Fund also collects a platform fee of 1% of each donation to cover part of our internal costs and to comply with federal law. Freedom Caucus Fund and Platform Fees are nonrefundable.
13. All contributions from multiple individuals must be drawn on a joint account.
14. Unless otherwise disclaimed, all donations to candidates or committees are earmarked donations within the meaning of 11 C.F.R. §110.6(b) to the Freedom Caucus Fund (C00552851) for the designated recipient(s).
